**The SDGs – the European research and societal impact challenges,

Since the UN adopted the global sustainable Development Goals (SDGs) for 2016 – 2030 - 2050, they have become a core concept of European and national funding strategies within a global context. Science, technology and research within the field of the bio-economy and the agro, food, aqua, and forest sector(s) are vital means to reach and implement the SDGs.
